Honorary members shall enjoy all the rights and privileges of Regular Members but shall not have the right to vote or to hold Executive office.

Retired members shall enjoy all the rights and privileges of Regular Members but shall not have the right to vote or to hold Executive office.

Associate Members shall enjoy all rights and privileges of regular members but shall not have the right to vote or to hold office.
