Any member may nominate an individual for this honor to the Executive. Honorary members shall enjoy all the rights and privileges of Regular Members but shall not have the right to vote or to hold Executive office.

Retired members shall enjoy all the rights and privileges of Regular Members but shall not have the right to vote or to hold Executive office.
