	(B)	Corporate Member: \$500.00 + HST Corporate Members shall be any firm, business or company allied to, or associated with, the building industry and dedicated to the protection and enhancement of public safety excluding Municipal, Federal, Provincial Governments and their Departments, Agencies, Commissions etc. Corporate members shall enjoy all the rights and privileges of Regular Members, but shall not have the right to vote or to hold Executive office.
	(C)	Honorary Member: Pays No Dues Honorary memberships shall be restricted to individuals who have rendered outstanding service to the furtherance of the purposes and objectives of the Association. Honorary membership shall be conferred upon the recommendation of the Executive and approved by majority vote of the members present at the Annual General Meeting. Any member may nominate an individual for this honor to the Executive. Honorary members shall enjoy all the rights and privileges of Regular Members but shall not have the right to vote or to hold Executive office.
	(D)	Retired Members: Pays No Dues A person who has retired and has been a Regular Member of the Association and is not actively practicing in the field of building inspection. Retired members shall enjoy all the rights and privileges of Regular Members but shall not have the right to vote or to hold Executive office.
	(E)	Associate Members: \$300 + HST Associate Membership is granted to person(s) working or engaged in the design, construction, or building safety enforcement sectors. Associate Members shall enjoy all rights and privileges of regular members but shall not have the right to vote or to hold office.
